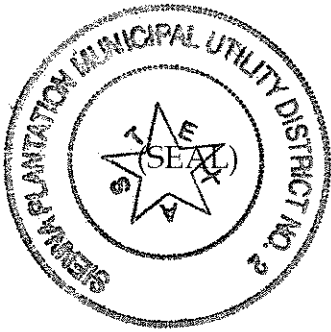

Notice is hereby given that the Board of Directors of Sienna Plantation Municipal Utility District No. 2 will hold a regular meeting, open to the public, on *Monday, March 19, 2007, at 12:00 p.m., at the offices of ECO Resources, Inc., 12535 Reed Road, Sugar Land, Texas 77478*, outside the boundaries of the District, for the following purposes:

    - ii. Steep Bank Village Ditch Project, Phase IV.
  - b. Approve pay estimates, time extensions and change orders, if necessary, for water, sewer and drainage facilities for projects in the service area:
    - i. Steep Bank Village Ditch Project, Phase I (Special Projects Account).
    - ii. Steep Bank Village Ditch Project, Phase II (Special Projects Account).
11. Authorize Financial Advisor to solicit proposals for Revenue Anticipation Note and authorize appropriate action.
12. Receive Operator's report, and authorize appropriate action.

13. Conduct hearing on termination of water service to delinquent customers.
14. Discuss joint maintenance agreement with Sienna Plantation Residential Association, Inc. and authorize appropriate action.
